Statistical Report:

Family Services Manager Melinda Hall presented certificates to Floyd County for having the highest average daily attendance, Johnson County for having the highest volunteer hours, and Paintsville for having the highest parent meeting attendance. It was noted that three of the delegates have not maintained the required 85 percent attendance.

December 1 Disability Numbers:

Disability Services Manager Debbie McKenzie shared the disability report to members. She explained that 10 percent of the program's overall enrollment must be children with disabilities. That number has already been obtained with a total of 15 percent children with disabilities program wide. She went through the current numbers for each program and talked about RTI and how children go through the process of determining whether an IEP is needed.

2016-17 PIR Report:

Mr. Jenkins provided statistics from the 16-17 PIR to council members. He recognized many positive aspects of the report. He also noted that dental treatment is always an area of concern considering that we only have two pediatric dentists in the area that accept a medical card. This is why our numbers are always lower in this area. There were several questions from the members and Mr. Jenkins told the group that he could provide them with many other statistics if desired.

Approval to Apply for Funding To Purchase A Mobile Unit:

Due to trouble meeting enrollment numbers, Mr. Jenkins discussed the possibility of closing a Martin County classroom and purchasing a mobile unit and opening another classroom in the Pike County delegate at Pike Central Elementary. He said this would help serve the Mullins children that are traveling to the Johns Creek area for the nearest HS classroom. He said that he has only got one quote in the amount of \$175,000 but is working on gathering more quotes. Ms. Adkins asked for a motion to approve requesting funding from the regional office at a minimum of \$175,000.
